

**LCP 200+ CLIMBING CLUB**

**Release/Indemnification of All Claims,  
Covenant Not to Sue and Assumption of Risk**

NOTICE: THIS IS A LEGALLY BINDING AGREEMENT. By signing this agreement, you give up your right to bring a court action to recover compensation or obtain any other remedy for any injury to yourself or your property or for your death however caused arising out of your use of the facilities (hereinafter "Climbing Wall") of the LCP 200+ CLIMBING CLUB. (hereinafter "200+ CLUB") now or any time in the future.

**Acknowledgement of Risk**

I HEREBY ACKNOWLEDGE AND AGREE that the sport of rock climbing and the use of the Climbing Wall has inherent risks. I have full knowledge of the nature and extent of all the risks associated with rock climbing and the use of the Climbing Wall, including but not limited to:

1. All manner of injury resulting from falling off the Climbing Wall and hitting rock faces and projections, whether permanent or temporarily in place, or the floor;
2. Rope abrasion, entanglement and other injuries resulting from activities on or near the Climbing Wall such as, but not limited to, climbing, belaying, rappelling, lowering on rope, rescue systems and any other rope techniques;
3. Injuries resulting from falling climbers or dropped items, such as, but not limited to, ropes or climbing hardware;
4. Cuts and abrasions resulting from skin contact with the Climbing Wall;
5. Failure of ropes, slings, harnesses, climbing hardware, anchor points or any part of the Climbing Wall structure.

I further acknowledge that the above list is not inclusive of all possible risks associated with the use of the Climbing Wall and that the above list in no way limits the extent or reach of this release and covenant not to sue.

**Release/Indemnification, Covenant Not to Sue and Assumption of Risk**

In consideration of my use of the Climbing Wall, I, \_\_\_\_\_, the undersigned user, agree to release and on behalf of myself, my heirs, representatives, executors, administrators and assigns, and HEREBY DO RELEASE 200+ CLUB, its officers, agents and employees from any cause of action, claims or demands of any nature whatsoever, including, but not limited to, a claim of NEGLIGENCE, which I, my heirs, representatives, executors, administrators and assigns now have, or acquire in the future against 200+ CLUB on account of personal injury, property damage, death or accident of any kind, arising out of, or in any way related to, my use of the Climbing Wall, whether that use is supervised or unsupervised, however the injury or damage is caused, including, but not limited to, the NEGLIGENCE of 200+ CLUB, its officers, agents and employees.

In consideration of my use of the Climbing Wall, I, the undersigned user, agree to INDEMNIFY AND HOLD HARMLESS 200+ CLUB, its officers, agents and employees from any and all causes or action, claims, demands, losses, or costs of any nature whatever arising out of, or in any way relation to, my use of the Climbing Wall.

I hereby certify that I have full knowledge of the nature and extent of the risks inherent in the use of the Climbing Wall and that I am voluntarily ASSUMING THE RISKS. I understand that I will be solely responsible for any loss or damage, including death, I sustain while using the Climbing Wall and that by this agreement, I am relieving 200+ CLUB, its officers, agents and employees of any and all liability for such loss, damage or death.

I further certify that I am in good health and that I have no physical limitations which would preclude my safe use of the Climbing Wall.
